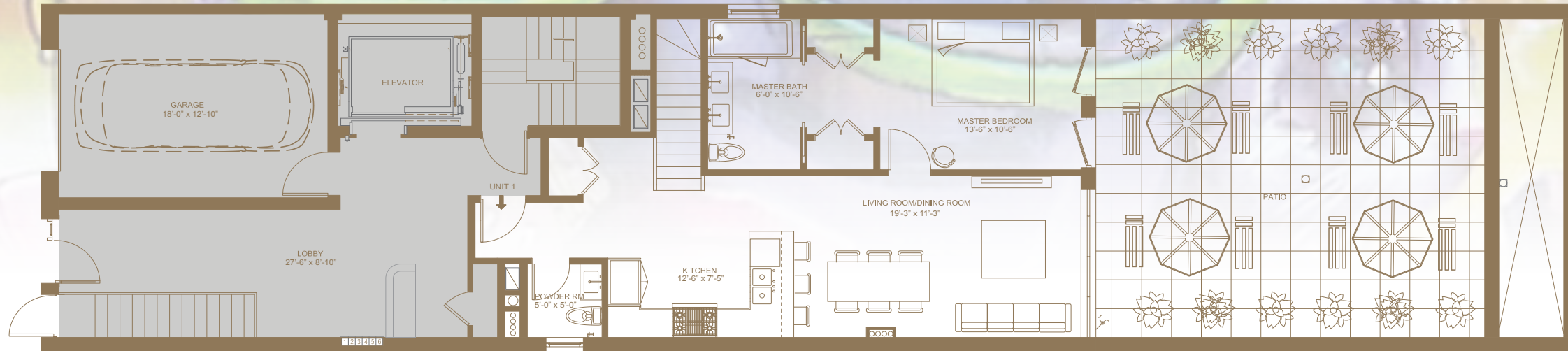


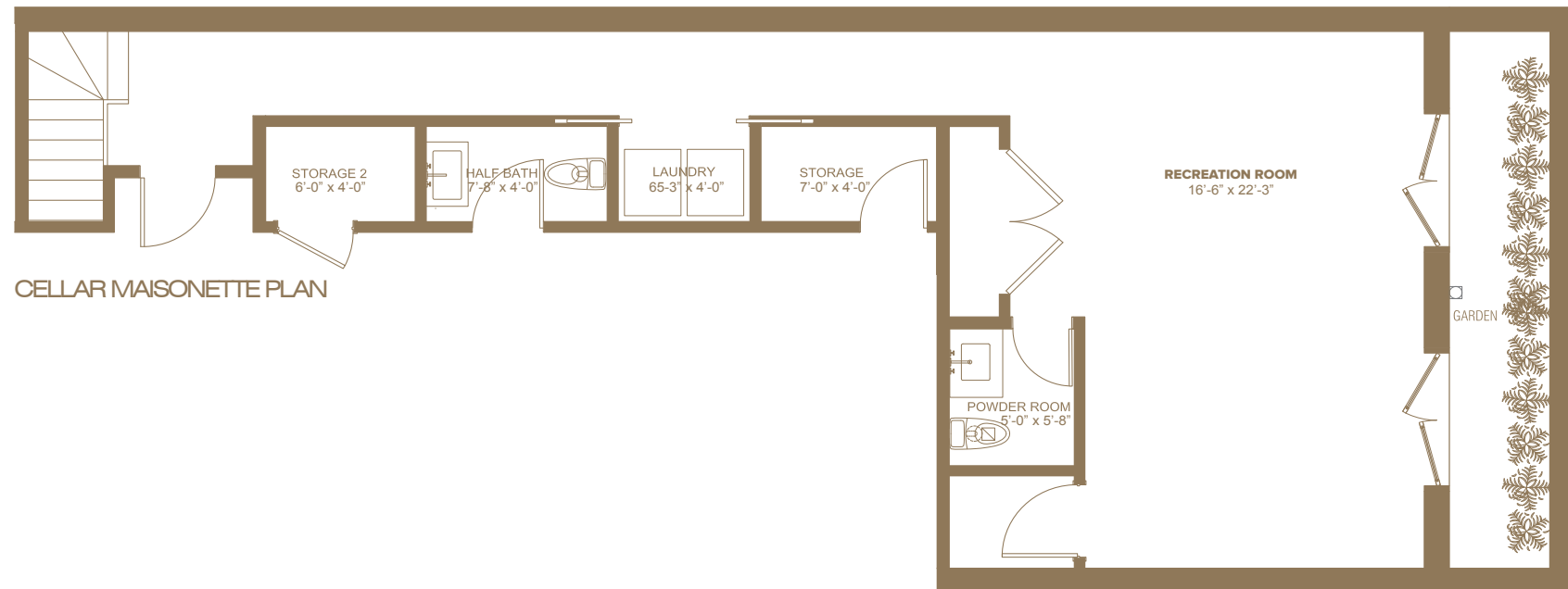

CELLAR MAISONETTE PLAN

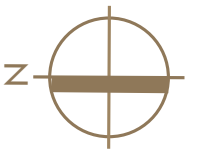
